ADDITIONAL TERMS AND CONDITIONS

Please note that for all future reference, “Service/Speaker” shall refer to Webbed Media and/or Ms. Webb and “Organization” and/or “client” shall refer to _____, including its representative(s).

Equipment. Client agrees to furnish, at its own expense, all that is necessary for the proper presentation of the speaking/workshop presentation of booking. All equipment that is necessary for the proper presentation of service will be provided by Webbed Media at its own expense.

Force Majeure. No party shall be liable for any failure to perform its obligations under this Agreement where such failure is proximately caused by circumstances or events not reasonably in the control of either Party, including: detention or prevention by sickness, accident, means of transportation, any act or order of any public authority or any other cause, similar or dissimilar, beyond Service/Speaker control; Acts of God/nature (including flood, fire, storm, tornado, earthquake, hurricane, and other natural disasters), war, terrorism, riot, epidemic, labor difficulties, strike and other industrial dispute, or by any law, regulation, order, or other action by any public or regulatory authority. If, due to Force Majeure, the event can not take place, Service/Speaker will attempt to reschedule within 6 months of the original booking date. However, Organization is still responsible for paying the full contract price if the engagement is interrupted and/or discontinued during the performance due to a Force Majeure.

Use of Speaker Image, Likeness and Work. Organization shall not have the right to broadcast or televise, photograph or otherwise reproduce the performances, services and or work hereunder, or any part thereof without written consent of Service/Speaker or Service/Speaker’s Representative. Client shall not have the right to assign this agreement or any provisions hereof. Nothing herein contained shall ever be construed as to constitute the parties hereto as a partnership or joint venture, or that the Service/Speaker shall be liable in whole or in part for any obligation that may be incurred by client in client’s carrying out any of the provisions thereof, or otherwise. The person executing this agreement on Client’s behalf warrants his/her authority to do so, and assumes liability for the payment of said price in full.

Performance to Others. If, before the date of any scheduled performance, it is found that Organization has not performed fully its obligation under any other agreement with any party for another engagement or that the financial credit of the Organization has been impaired, Service/Speaker may cancel this agreement. In the event that Organization does not perform fully all of its obligations herein, Service/Speaker shall have the option to perform or refuse to perform hereunder and in either event, Organization shall be liable to Service/Speaker for damages in addition to the compensation provided herein.

Default. Client shall be deemed to be in default of any balance which remains unpaid under this contract as of the performance date and time set forth in this contract and shall be subject to suit or other means of collection of this unpaid balance. Unpaid balances will accrue at an interest rate of 18% annually (1.5% month). Client shall be responsible for all costs, filing fees and reasonable attorney's fees incurred by Service/Speaker required in the collection of the unpaid balance.

Legality. This Agreement may not be changed, modified, or altered except by an instrument in writing, signed by the parties. This Agreement shall be construed in accordance with the laws of the State of New York. Nothing in this Agreement shall require the commission of any act contrary to law or to any rule or regulation of any union, guild, or similar body having jurisdiction over the performance(s) hereunder or any element thereof and wherever or whenever there is any conflict between any provision of this Agreement and any such law, rule or regulation, such law, rule or regulation shall prevail and this Agreement shall be curtailed, modified, or limited only to the extent necessary to eliminate such conflict.

Arbitration. Any claim or dispute arising out of or relating to this Agreement or the breach thereof shall be settled by arbitration in the State of New York in accordance with rules and regulations then obtaining of the American Arbitration Association governing three member panels. The parties hereto agree to be bound by the award in such arbitration and judgment upon the award rendered by the arbitrators may be entered in any court having jurisdiction thereof.
